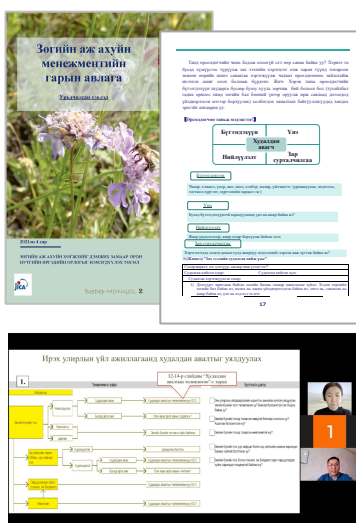
BeeDep-MONGOL 2



Manual on beekeeping business management (ver.2) will be available soon!

The target location of the BeeDep project is Darkhan-Uul Province. Based on the activities carried out in this area, we have been working to develop an integrated manual for beekeeping. Last year, as part of this manual, a preliminary version for Beekeeping and Honey Quality and Business Management (Ver. 1) was prepared.

An updated version of the Beekeeping Business Management Manual (Ver. 2) is being prepared based on the feedback and collaboration that has been generated so far. The updated version will help to gain practical knowledge such as the advantages of the beekeeping product, the attitude of the target customers, the method of calculating the production cost, and the creation of a branded product. The updated version (Ver. 2) is scheduled for release in the second half of April. In March, we produced online lessons (No.16-19) on the topics included in the Business Management Manual and posted it on the project's Facebook page. Please see them.

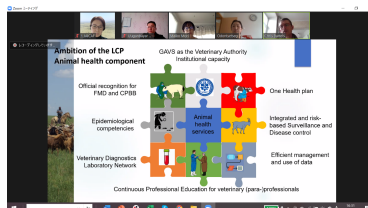

We have been expanding cooperation with other stakeholders

On March 3, a tri-lateral meeting was held with the Livestock Commercialization Project (LCP), implemented in Mongolia by the Food and Agriculture Organization of the United Nations (UN FAO), and the JICA Project for Formulation of Master Plan on the Agricultural Value Chain in Mongolia (JICA-MONMAP). The LCP project has been developing a Continuing Professional Development program for veterinarians, and the BeeDep project has collaborated on the Bee veterinary medicine package. The JICA-MONMAP project also plans to provide training for veterinarians and food safety inspectors as part of the pilot project on honey using the results of the BeeDep project.



An online meeting was held with the TVET in Bulgan Province on April 6. The "Bulgan Bee" program has been implemented in Bulgan Province since 2019. This spring, as part of the program, the TVET has launched a new class to prepare beekeepers. Our project provided information on collaboration opportunities and training programs.

The BeeDep project will exchange information with relevant organizations on a regular basis and collaborate.
